Minutes of a Meeting of the NH Association of Fire Chiefs

Virtual

Thursday, September 10, 2025

Called to order at 0904 hours by Chief Watkins.

After a salute to the flag, a moment of silence was requested for departed members.

President's Report: (Watkins) –

Report of the Executive Director: (Lemire)

- Our October meeting will be on the 9th at the NH Fire Academy including breakfast.
- The November 13 meeting will be at 0900 and virtual.
- The December 11 meeting will be at the Nashua Country Club beginning at 1700 hours.
- We advertised the BCRB position for a second time and got two candidates. Chief James Reinert of Alton was chosen to represent us.
- He has reserved our table at the North Country Public Safety Awards dinner on November 14. It is a budgeted item.
- Ad book proceeds to date: Total: \$23,565.50; Vendor: \$16,495.50; Assn: \$7,069.50.

1st Vice President Report (LaRoche) -

Government Relations – (Schmidt) –

The Legislature is slowly starting to return to Concord after their summer break. Committees will consider bills that were retained (House) and re-referred (Senate) in the fall. House Committees have to report on their retained bills by November 21. The Senate does not have a formal deadline. The House and Senate will vote on the committee reports during their initial sessions in 2026. There were several other deadlines and updates NHAFC members of which NHAFC members should be aware:

- **Senate Filing Deadline** Senators have until Friday, September 12 to file bills for the 2026 session. We should see titles before too long. The actual text of bills will not be made public until later this year or early next year.
- **House Filing Deadline** House members can file bills between Monday September 15 and Friday, September 19. Again, we should see the titles before too long.
- Veto Day The House and Senate still have not finalized when they will return
 to Concord to consider vetoes issues by Governor Ayotte. In total, the Governor
 issued 15 vetoes. There is speculation that they may wait until January to take up
 the vetoes. Nothing has been confirmed yet. Two of the bills which were vetoed
 were of interest to NHAFC:

GOVERNOR'S VETO MESSAGE REGARDING HOUSE BILL 475

Recruiting and retaining first responders is of paramount importance for public safety, and local departments across our state are facing enough difficulty with this already.

This bill will make it even harder to hire police and fire personnel. The New Hampshire Association of Fire Chiefs and Association of Police Chiefs have written me that 'this bill, should it be signed into law, will have far reaching effects for public safety... [and] increase the length of time for roads to be plowed, fire department coverage, police response, and staffing.' It is also an unnecessary overreach by the State into municipal affairs.

GOVERNOR'S VETO MESSAGE REGARDING SENATE BILL 213

I am vetoing this legislation as it conflicts with other bills I have recently signed into law regarding absentee ballots. Additionally, I intend to work the with the bill sponsors on the issue of electioneering to ensure that public employees can engage in public discourse without misusing their official positions for political purposes.

• New Location for House Hearings — For the 2026 session, the House will not be having committee meetings in the Legislative Office Building (aka LOB, the building directly behind the State House). The building is going through a major renovation. House Committee meetings will be held at 1 Granite Place, Concord, NH 03301. The following directions appeared in the most recent House Calendar "....Legislative Offices at Granite Place are in the South building. From I-93 N or S, take exit 15W. At the lights, take a right to head north on Route 3 / Bouton St. At the next set of lights, stay straight as the road turns into N. State St. At the next set of lights, take a left on to Penacook St. At the stop sign, take a right turn on to Rumford St. Granite Place is the next left turn." The House will hold their sessions in the State House, but if Chiefs plan to attend any House hearings, it will be important to note the new location.

2nd Vice President Report (D. Chamberlain) –

<u>Fire Marshal:</u> (Marshal Toomey) ADMINISTRATION:

Personnel:

We are recruiting for a part-time Hazardous Materials Coordinator, a full-time Fire Protection Specialist and a full-time Fire Investigator. We have submitted hiring waiver requests for a full-time Hazardous Materials Coordinator, a full-time Fire Protection Specialist, a full-time Building Inspector, a part-time Recreation Ride & Lift inspector, and a part-time State Building Permit Coordinator.

Legislation:

We are currently collaborating with the Commissioner's office and our stakeholders on potential legislative proposals for the upcoming session.

Board of Fire Control:

The next Board of Fire Control meeting will be held on September 16, 2025, at 1:00 pm.

BUREAU OF INVESTIGATIONS:

In August, we received 14 incident notifications resulting in 8 scene responses. The Bureau of Investigations currently has 8 open arson or suspected arson investigations.

New cases (synopsis of some of our cases are listed below):

- On August 4, investigators responded to a structure fire in Surry, where one occupant sustained injuries. The cause of the fire is still under investigation; however, no criminal indicators have been identified to date.
- On August 7, investigators and a K9 team responded to Northumberland to assist with an investigation into the origin and cause of a structure fire. While the investigation is still ongoing, investigators have identified criminal indicators that suggested this fire was intentionally set.
- On August 13, investigators responded to Conway to offer support as there had been several fires. Investigators consulted with the Conway Fire Department (CFD) at one fire scene, which was at a hotel. CFD will be

- leading the investigation. The fire is suspected to have been one of several fires that were started by sparks from a commuter train passing through.
- On August 16, investigators responded to Derry to assist the Derry Fire Department (DFD) and the Derry Police Department (DPD) with an incendiary fire. The investigators collaborated with DPD and DFD to obtain search warrants, which were granted and executed. A suspect has been identified, and DPD plans to pursue criminal charges. Meanwhile, DFD will complete the Origin and Cause Report. Investigators collected evidence from the scene, which has since been sent to the NH State Police Crime Laboratory to undergo analysis.
- On August 17, investigators responded to Bartlett to assist with a fire involving a motor vehicle. Initially, the Bartlett Police Department had concerns that the vehicle involved in the fire may have been intentionally set on fire. At this time, investigators do not believe that to be the case, however; the investigation is ongoing.
- On August 27, investigators responded to Gilford to assist with a fire investigation at a historical structure. Working alongside the Gilford Fire Department and the Gilford Police Department on the scene, the investigators collectively determined that the fire had been intentionally set. This investigation is currently active and ongoing. The Fire Marshal's Office will be responsible for determining the origin and cause of the fire, as well as any potential criminal charges that may arise from the evidence and information gathered during the investigation.
- On August 30, investigators responded to a building fire in Franklin at the
 request of the Franklin Fire Department. Investigators determined that the
 fire was incendiary. This investigation is currently active and ongoing. The
 Fire Marshal's Office will be responsible for determining the origin and
 cause of the fire, as well as any potential criminal charges that may arise
 from the evidence and information gathered during the investigation.

Fatal Fire/CO Incidents:

• On August 11, investigators responded to a structure fire at a residential home in Deerfield, NH. The sole occupant of the home was initially unaccounted for, so investigators collaborated with personnel at the scene. After some time, the occupant was located and confirmed to be deceased. The individual was a 63-year-old woman who lived alone in the home. The investigation into the origin and cause of the fire is ongoing. Although the cause of the fire remains undetermined, there is currently no evidence to suggest that it was the result of a deliberate or criminal act.

Arrests/Court:

• On July 29, investigators responded to an incident in Gorham to assist with a fire investigation. During the investigation, both on-site and in subsequent days, evidence was discovered that indicated the fire had been deliberately set. On August 8, investigators identified a person of interest and conducted interviews with this individual, as well as with witnesses. This led to the suspect's confession regarding the initiation of the fire. The suspect, Travis M. Davis, aged 32, of Gorham, was arrested and subsequently taken to a detention center, where he was held under preventive detention pending court proceedings. The investigation into this case is ongoing and remains active.

• Investigators were present at the School Resource Officer (SRO) Conference engaging with officers regarding awareness and information regarding Youth Firesetters.

BUREAU OF BUILDING SAFETY & CONSTRUCTION:

School Fire & Life Safety Inspections for the 2025-2026 Academic

Year

As students across New Hampshire prepare to return to their classrooms for the 2025–2026 school year, the New Hampshire State Fire Marshal's Office would like to take this opportunity to remind local fire chiefs and their staff of the requirements surrounding School Fire & Life Safety inspections.

Per state law, local fire chiefs are responsible for conducting annual fire and life safety inspections of all public and private schools within their jurisdiction. These inspections must be performed while school is in session—during regular academic operations—not during summer recess or other school breaks. Conducting inspections during active occupancy ensures a more accurate representation of daily operations and allows for timely identification and resolution of any safety concerns.

According to the NFPA 101 Life Safety Code (2021 Edition), an educational occupancy is defined as: "An occupancy used for educational purposes through the twelfth grade by six or more persons for four or more hours per day or more than twelve hours per week."

These inspections are a critical component of the New Hampshire Department of Education's school approval process. Public schools must demonstrate compliance with NH Administrative Rule Ed 306.07, while non-public schools

are required to meet the standards outlined in NH Administrative Rule Ed 403.01(c).

RSA 153:14 Fire Safety Measures. II (b) Each local fire chief shall annually inspect all school buildings within his or her jurisdiction while school is in session and submit a written report to the state fire marshal on the condition of all such school buildings. A copy of the report shall be furnished to the school district superintendent, or personnel assigned to perform superintendent services under RSA 194-C:5, II(a), and school board members. The report shall detail any state fire code compliance issues in each school building. The report shall be submitted no later than December 15 each year.

For our recordkeeping purposes, school inspection submissions are categorized by academic year beginning August 1. For example:

- A report received on July 15, 2025 will be archived under the 2024 school year.
- A report received on August 15, 2025 will be archived under the 2025 school year.

We appreciate your continued commitment to ensuring the safety of New Hampshire's educational facilities. Should you have any questions regarding inspection procedures or documentation, please contact our office for further guidance.

Electric Vehicles and Lithium-Ion Batteries

The council to study the impacts of electric vehicles, e-mobility devices, and the associated lithium-ion batteries hazards for first responder response, the environment, building and fire codes, life safety, and property protection continues its work.

Have you started planning for <u>Fire Prevention Week</u>? This year's Fire Prevention Week[™] (FPW[™]) campaign, October 5-11, "**Charge into Fire Safety**[™]: **Lithium-Ion Batteries in Your Home,**" works to educate everyone about using these batteries safely. The campaign stresses how important it is to <u>BUY, CHARGE, and RECYCLE</u> safely when it comes to lithium-ion batteries.

The SFMO is working with NHDES to provide information about safe disposal of lithium-ion batteries. As of July 1, 2025, they are banned from disposal as solid waste and must be sent to a recycler. Some NH municipalities and businesses offer collection boxes for recycling rechargeable batteries. Participating retailers include Lowes, Home Depot, Staples and Batteries Plus. Local transfer stations will also accept lithium-ion batteries for recycling. Incident Reporting:

We continue to monitor the development of the U.S. Fire Administration's (USFA) new fire information and analytics platform, known as the National Emergency Response Information System (NERIS), for the American fire and emergency services. New Hampshire is scheduled for onboarding in October 2025.

As we have mentioned before, NFIRS, as we know it, will be going away for good on December 31, 2025. Please make sure that you have a plan for the transition to NERIS, which starts next month. If you are an e-NFIRS user, you should switch to the Image Trend Elite software now. Please contact the data analysis section at nhfirs@dos.nh.gov

to get started. If you have a third-party vendor software package, please contact your vendor and work with them to switch your data collection method over from NFIRS to NERIS sometime between October and December.

Data reporting will not occur in both systems simultaneously. Once you switch over from NFIRS to NERIS, you will not be required to continue reporting in NFIRS. Our goal is to eliminate the chance of gaps in data for the state. Please set your department up for success by preparing for NERIS now.

Thank you to the departments who responded to our recent survey in preparation for NERIS! Reach out to us at nhi:gov if you aren't sure whether your agency has responded. If you have not completed it, please do so quickly. Making sure that your contact information is up-to-date will be crucial when FSRI starts reaching out to agencies in October for onboarding.

We would like to remind all fire departments that if you experience a fatal fire or a fire with civilian injuries in your community, you will need to complete the Civilian Casualty module for your incident report in addition to calling our office for investigative assistance.

Outreach Events:

Throughout August, the New Hampshire State Fire Marshal's Office participated in 25 public outreach events and provided fire safety resources for three other events. On National Night Out (NNO), August 5th, it was all hands-on-deck to join 10 communities (and over 2,000 community members) across the state. Thank you for the invitation: Claremont, Somersworth, Lincoln, Goffstown, Rochester, Waterville Valley, Peterborough, Moultonborough, Loudon, and Concord with Sparky going to Greenland.

It was a busy month in Manchester. We enjoyed sharing fire safety education at CelebratED, an event hosted by Manchester Proud and celebrating first responders at a special community event at Harley Davidson. We also partnered with New Hampshire Homeland Security and Emergency Management and New Hampshire 911 to share public safety messaging and resources for staff at the Manchester City Library.



This August we celebrated with two fire departments for Rindge's 100th and Bridgewater's 50th anniversaries. Sparky appeared at Pittsfield's Annual Hot Air Balloon Rally with the NH Liquor Enforcement's Invest-I- 'gator," and Marine Patrol's Zippit. We attended the School Resource Officer Conference in Concord providing educators with information on resources and services we offer relative to youth fire setters. The NH SFMO participated in town wide safety days, touch-a-truck events, and first responder nights. Our K-9 teams visited Freedom's Old Home Day, Moultonborough and Concord during NNO, a Bow Summer Camp, Concord Karate, and taught a criminal investigation course.

Together, we communicated with a monthly total of 3,165 community members about the importance of working smoke and CO alarms, fire escape plans, and fire safety strategies. Thank you all for making August a success!


Public Education:

Our public education theme for September is "Heating Fire Safety." Although trending downward since the early 1980s, heating fires remained the second leading cause of home fires in 2021 in the nation. An estimated 32,200 home heating fires were reported to fire departments within the United States. These fires caused an estimated 190 deaths, 625 injuries and \$442 million in property loss.

Did you know:

<u>Home portable heater fires</u> were only 3% of all home heating fires annually for 2017-2019, but they accounted for 41% of fatal heating fires in homes.

Help prevent home heating fires: Remind residents about safe heating with space heaters, wood stoves and fireplaces with <u>free outreach resources</u>. USFA has home heating safety <u>resources</u> to share in your community. Prepare yourself and educate your community with these <u>resources</u> from NFPA.

<u>Fire Standards/Training/EMS</u> – (Director Wholey)

Personnel

- ➤ On January 22nd, Governor Kelly Ayotte signed an Executive Order instituting a hiring freeze across state government. We will work within the process to identify any positions that are eligible for a waiver under the order.
- ➤ We completed initial interviews for our two full-time Fire Training Captain positions.
- ➤ We have one vacancy for our full-time EMS Compliance Coordinator waiver approved.
- ➤ We have vacancies for 10 Staff Instructors waiver approved.
- ➤ We have vacancies for 4 Support O₅₁ personnel waiver approved.
- ➤ We have two vacancies for our part-time Program Coordinators waiver approved.
 - Promotional Testing
 - Fleet Mechanic for Heavy Equipment
- ➤ We have one vacancy for a full-time Program Specialist III (Education Technologist).
- ➤ We have one vacancy for our full-time Fire Training Instructor position.

- ➤ We have one vacancy for our part-time EMS Ambulance Inspection Coordinator.
- ➤ We have vacancies for EMS Exam Coordinators.
- We have vacancies for EMS Vehicle Inspectors.

Grants

- ➤ We submitted our application for the 2024 AFG grant and are waiting to hear additional information.
- We submitted our application for the 2025 National Fire Academy training grant.
- ➤ Bureau Personnel are in the process of gathering quotes for potential equipment purchases through the FEMA Grants.

Special Projects

- ➤ The early detection cancer screening pilot program RFP submission period closed on February 19th. Initial scoring on the technical portions of the proposals was held on March 7th. The Division is currently working through the contract process which will then be submitted to the Governor and Executive Council for consideration.
 - We anticipate this program will launch in Fall 2025.
 - We are developing a website dedicated to this program where eligible individuals can find information about the program.
- ➤ The Raymond S. Burton Fire and EMS Training Facility infrastructure project continues to move forward with completion of the project expected on or before November 2025.
 - Phase II which includes the heated garage and classroom building upgrades is ongoing.
 - Work continues on the classroom and garage buildings to finish interior work.
 - IPS performed air sampling on the Burton Training Facility Air Trailer.

 Classes and prop usages are being limited for this campus until construction is completed. All other classes will be moved to other



facilities in the area.

Legislative/Administrative Rules

- ➤ The 2025 legislative session continues. We are monitoring many legislative Bills.
 - Among the monitored bills which passed are HB316, SB133, SB 202, and SB 24, which relate to EMS providers.
 - HB2 transferred the responsibilities of licensing Wheel Chair for Hire Companies and associated vehicles from the Division to the Department of Health and Human Services.
 - SB245 passed with an amendment on July 31st, prohibiting surprise ambulance billing and regulating ground ambulance reimbursement.
- ➤ The proposed Trauma Rules are working through the internal DOS process.
- An EMS discipline and other various administrative rule changes proposal has been adopted on July 22, 2025. These changes were supported by the EMS Coordinating Board and allow for deceased providers names to be removed the public listing, along with other various changes to the ruleset.
- ➤ Administrative Rules to make the full transition to ETA's and sunset the former process have been developed and are working through the internal DOS process for submission to JLCAR.

Outreach

> Staff members continue to attend various stakeholder and mutual aid group meetings and make department visits.

As a reminder, visiting committee meetings are public and anyone who is interested in the development of training programs is invited to attend. The application for Driver-Operator Visiting Committee closed on August 8th.

Future Program Development

- ➤ EMS in the Warm Zone. Captain Cartier and Maria Varanka are overseeing an update to the Awareness, Operations, and RTF Concepts levels of EMS in the Warm Zone program. This update seeks to align the program with the newest versions of NFPA 3000 and the Committee on Tactical Emergency Casualty Care (C-TECC) guidelines for First Responders with a Duty to Act.
- ➤ Interfacility Transfer. Captain Robblee and Rachel Larry will be overseeing an EMS Visiting Committee to revise the IFT and PIFT training programs. The application to join the curriculum committee closed on August 15th.
- ➤ Fire Officer (I & II). The new NFPA standards for Fire Officer Professional Qualifications (NFPA 1020) were released at the beginning of the year. Captain Burns and Program Coordinator Meyer will begin work in preparation for a visiting committee early next year.
- ➤ Fire and Emergency Services Instructor (I, II, & III). The new NFPA standards for Instructor professional qualifications (NFPA 1020) were released at the beginning of the year. Chief Bibeau and Program Coordinator Field will begin work in preparation for a visiting committee early next year.

Accreditation

- ➤ The five-year process of re-accreditation through The Pro Board has begun. This process involves completing a comprehensive self-assessment of the Division's policies and certification exam practices, and a resubmission of all assessment instruments used by the Division for accredited certification exams.

The site visit team will review the Division's policies, testing procedures, examination materials; interview instructors, students, and commission members; and make recommendations for improvement. This visit will determine the Division's accreditation status for the next five years.

 - There are currently 15 licensed ETAs with 6 more in the process of being licensed.
 - Routine site visits for ETAs will start in September.

- The Division continues to expand the capabilities of the RespondNH system. As we utilize this system and analyze more data, it is important to have department roster information updated and current. Each department has the full capability to manage their own roster by adding new staff and removing those that may have left and may be done at any time. For State level reporting information, fill out your roster information to include their status (career, call, or volunteer) and the duties they provide, such as EMS care and/or fire suppression.
- > EMS Instructor Initial/Reinstatement and Instructor Renewal applications are available online for licensing.
- ➤ The monthly EMS and Fire Reporting Users groups have restarted.
- ➤ We are working with EMS agencies using 3rd party ePCR software to improve their reporting completeness and overall data quality.

Compliance

- There are currently 7 active investigations and ongoing cases.
