Minutes of a Regular Meeting of the NH Association of Fire Chiefs

Thursday, January 13, 2022 - Virtual via "Go To Meeting" platform

The meeting was called to order at 1604 hours by Chief Beattie.

After a salute to the flag, a moment of silence was requested for departed members.

Chief Beattie welcomed everyone to the meeting.

Member Introduction: Members' attendance was polled by the Executive Director.

Special Guests:

Minutes of the December 9 meeting will be posted. Approval will be deferred to February.

Financial Reports: The November and December financials have been posted. A MOTION (Thomas/Fraitzl) to approve them carried unanimously.

President's Report: (Sitar) -

Executive Director's Report (Lemire) -

- Chief Scott Hunter of Bedford has been recommended for the Board of Fire Control position vacated by Chief Gagnon.
- The board has concurred that we will continue with virtual meetings until the virus surge abates.

- I am working with Primex and the Mt. Washington Hotel on our cooperative May 12, 2022 meeting. The Primex room rate this year is \$199, which will be extended to our group also.
- June will be in Brookline, hosted by Chief Corey.
- I will also be working with Nick at LRCC on a meeting discussing several options including the Annual Meeting.
- I have been working with Chief Paul Parisi to finalize the production of the ad book. I've provided him with pictures, letters, history information and Justin is sending him an up-to-date NH list of fire chiefs.

1st Vice President Report (Beattie) –

- Continue to assist with the legislative review of newly filed bills
 - o I will allow Chief Emmanuel and Adam Schmidt to speak to the specifics
- Attending hearing on 1/13/22 reference HB 1548, relative to the sale of the State School property in Laconia
 - Represented both LRMFA Executive Committee and NHAFC
 - o Sale affects Lakes Region fire dispatch (LRMFA) and E911
 - 35 Communities affected as part of LRMFA
 - Not for or against sale, but supporting zero cost to the 35 communities when these agencies need to move
 - We have been working successfully with Governor Sununu, Commissioner Quinn and Director Doyle on this issue
- Attended meeting with Marshal Toomey and others to discuss recovery housing
 - o Allows voice from NHAFC to mirror/support Marshal Toomey
 - o These homes are in multiple communities across state and growing
 - Key question is how do we meet their want with our needs of fire and life safety?
- The BOD voted to send Chief Scott Hunter's name to the Governor for the position of Municipal Fire Chief Representative to the Board of Fire Control. Awaiting Governor and Council approval.

2nd Vice President Report (Emanuel) -

This week's House and Senate calendars included many initial public hearings for bills that the NHAFC is following. The legislative calendar below includes all of the various bills that have been scheduled to date. (Links connect to the bills) As you will see, the next few weeks will be pretty busy. There were several bills and issues we wanted to highlight:

• **SB 377 (PTSD in State Troopers)** – It may make sense to follow the debate on this bill. It creates a new presumption for PTSD for state troopers. Under the

- "methodology" section of the bill states that the Department of Labor assumed the intent was "... to either broaden or clarify the existing presumption."
- •SB 363 (Group II/qualified service eligibility) Again, reading from the "methodology" section of the bill "...This bill allows Group II New Hampshire Retirement System (NHRS) members who commenced service between January 1, 2001 and December 31, 2011 to be entitled to receive credit for not less than one year and not more than four years of non-qualified service. The new provisions are as follows:
 - A member's purchase of the service credit is limited to the amount which will reduce the minimum age of retirement to the previous minimum age of 45.
 - Years purchased are to have an annuity multiplier of 2.5%.
 - The member is to pay a sum equal to their annual rate of compensation multiplied by the sum of the member and employer contribution rates in effect with respect to the member at the time of buy-in multiplied by the number of years of non-qualified service credit purchased."
- **SB 443 (Codes)** I believe we may have seen similar legislation in the past. The bill would require the BCRB to approve local amendments to the state building code prior to adoption. There are additional requirements for the fire marshal to approve local amendments to the state fire code prior to adoption and enforcement.
- House Executive Departments and Administration Thursday, January 13 Looks like House ED and A made next Thursday their first day to review a myriad of retirement related bills. The bill which PFFNH requested (HB 1587/average final compensation) is **NOT** part of the schedule for the day.
- **PTSD/Suicide First Responders** A week from Wednesday, the Senate ED and A committee will hear two bills. SB 227 includes suicide under the definition of "killed in the line of duty" when considering eligibility for death benefits of first responders. SB 357 re-establishes the PTSD Commission. NHAFC would retain their seat on the Commission in the bill. The bill also proposes mental health training for fire and EMS.

HB 1272 (town health officer) – Several Chiefs have expressed opposition to the bill. We confirmed that NHMA will be opposed. NHAFC is opposing the bill and seeking Chiefs who may want to testify.

BUREAU OF INVESTIGATIONS:

<u>New/Active cases (synopsis of some of our cases are listed below):</u>

• On December 9, 2021, investigators responded to a fire at 36 Lodge Rd. in Lincoln, which is a condominium complex where units can be rented out, similar to a hotel. LFD Chief Beard requested the FMO after

conducting a preliminary origin and cause investigation. The investigation revealed a fire set on the exterior porch which caused a charge of smoke to enter the unit and the hallway and the fire alarm to activate. The suspect, Mark Rosenberg, admitted to lighting the fire before leaving the area. Rosenberg has a history of mental illness and was voluntarily admitted to a local hospital for psychiatric evaluation and care prior to his release and subsequent arrest.

- On December 24, 2021, investigators responded to 2725 Westside Rd. in North Conway, Lot #44, to assist the North Conway Fire Department with a fire investigation in a mobile home. The investigation revealed a room and contents fire that was intentionally set by a renter. Investigators completed a prayer and complaint for an adult female in need of psychiatric care.
- On December 29, 2021, investigators responded to 67 Main St. in Antrim to assist the Antrim Fire and Police Departments with a fire investigation in an occupied apartment building. A fire was intentionally set in a hallway. The investigation into the incident is ongoing.
- Ongoing case work is being done in a joint effort with the FBI, NH State
 Police and other local NH police departments in a series of motor vehicle
 thefts involving gang activity. One of the stolen motor vehicles was
 discovered burned in the Lakes Region with additional new information
 suggesting the vehicle fire was intentionally set.

Fatal Fire:

- On December 16, 2021, investigators were notified by the Medical Examiner's Office of a possible fire related fatality that had occurred at 192 Lancaster Rd. in Northumberland. An autopsy later that day confirmed that 70-year-old Brian Connor had died from smoke inhalation. The investigation into the circumstances surrounding the incident are ongoing.
- On December 19, 2021, investigators responded to an RV fire fatality at 45 High St. in Manchester. The female victim, 34-year-old Chandel Vanenburg, was positively identified at autopsy and died from smoke inhalation. The investigation into the fire is open and ongoing.
- On December 31, 2021, investigators responded to a report of an explosion with one fatality at 32 New Hampton Rd. in Franklin. The investigation into the circumstances surrounding the incident identified that the explosion and fatality occurred as a result of the misuse of a propane tank. The victim, 44-year-old Nathaniel Krauz, was positively identified and died from blunt force trauma.

Ignitable Liquid Detection Canine Teams:

Our two IGL Canine Teams were deployed two times in the month of December. One K9 demonstration was conducted in December for a fire investigation class at Lakes Region Community College.

Public Outreach:

Investigators, in conjunction with the Nashua Fire Rescue's Fire Marshal's Office and ATF, provided an informational session to members of the Nashua Police Department on December 2, 2021. The presentation covered basic fire behavior, fire scene awareness, evidence collection, resources the FMO and ATF can provide upon request, and the importance of a team approach between the NPD Detectives and the NFR Fire Investigators in successful arson cases.

Investigators presented a case study to NH fire service and law enforcement, titled *Catching a Serial Arsonist*, which was held at the NH Fire Academy Auditorium on December 7, 2021 from 6:00-8:30PM. Feedback from the presentation has been positive, with several communities wanting to request FMO assistance based on what they learned.

Two of our investigators taught the Warrants and Citations class to fire service personnel involved in fire code enforcement.

Investigators are assisting with youth fire setter assessments in multiple communities throughout the state.

Arrests:

- Kathy Canfield, age 60, was arrested via a FMO warrant in connection with an arson fire that occurred in an apartment building, located at 4 Commerce St. in Hill on November 22, 2021. CANFIELD was arraigned on December 27, 2021, at Merrimack Superior Court on charges of one count of Arson (Class A Felony) and one count of Breach of Bail (Misdemeanor A) from two unrelated previous felony charges. Following her arraignment, she was released on PR bail and is awaiting a trial date due to COVID.
- Mark Rosenberg, age 58, was arrested via a FMO warrant in connection with an arson fire that occurred in a hotel located at 36 Lodge Rd in Lincoln on December 9, 2021. Rosenberg was released on PR bail and is currently being held in Massachusetts on separate charges.

Training/Committees:

Investigators attended an in service training on our new records management system. Several investigators attended: How to Navigate the Joint Fire & Death Investigation, High Tech Crimes and IAAI Is the Fire Accidental.

BUREAU OF BUILDING SAFETY & CONSTRUCTION:

State Building Permit System:

We processed 33 building permit applications in the month of December.

<u>Technical Assistance, Educational & Healthcare Reviews:</u>

We initiated 9 educational and 6 healthcare plan reviews, completed 109 inspections and 99 technical consults in the month of December.

Variance Requests:

We processed 3 variance requests in the month of December.

BUREAU OF PLANNING AND SUPPORT SERVICES:

Hazardous Materials:

Hazardous Materials response, coordination and consultation is available through the on-call FMO supervisor.

We continue to work on Tier II reporting and associated follow-ups when deficiencies are identified.

Swiftwater Rescue Working Group:

Working to identify funding and training opportunities for the teams. We anticipate a grant application announcement out to the teams in mid to late January.

All-Hazards Fire Mobilization Plan:

The Federation of Mutual Aids and the State Fire Marshal's Office has completed the biannual review of the NH Statewide Fire Mobilization Implementation Master Plan. The updated plan will be made available shortly.

Community Risk Reduction & Community Outreach:

We have been delivering the Remembering When, a falls and fire prevention program for older adults in several communities.

Training:

We are working to schedule upcoming inspection training programs throughout the state. Please reach out if you are interested in hosting a program.

<u>NH Fire Standards, Training and EMS - (</u>Dir. Cutting)

ADMINISTRATION

Personnel

- ➤ We conducted the interview and evaluation process of hiring a fire training Captain on January 12th and expect to hold second interviews next week.
- Our new Administrative Assistant starts on January 14th.
- ➤ We have hired Mike Munck as our Part-time Compliance Specialist. Mr. Monk will be retiring soon as the Deputy Police Chief in Exeter.

- ➤ The Recruitment & Retention Coordinator and three Specialty Services positions have been advertised for applicants.
- > We have finalized position descriptions for the Drill-yard and Technical Rescue part-time program coordinators and have begun advertising them.
- ➤ Over 20% of our staff positions are currently vacant.

Grants

- ➤ We submitted an AFG 2021 grant for structural and wildland personal protective equipment, SCBA's, training mannequins and multi-gas meters.
- > We submitted a Homeland Security grant for computers, cameras and other related equipment for our educational technology section.
- ➤ We have begun working with our State partners to advance the Burton Fire and EMS Training Facility project however no projected start timeframe has been established.

Fire Standards and Training Commission / Curriculum

- The next Fire Standards and Training Commission meeting will be February 3rd at 0930 in Classrooms 5/6 in the dormitory building at the main campus. The Commission also approved meeting dates for April 7th, June 2nd, September 1st and November 3rd.
- ➤ The Hazardous Materials Technician program and Fire Officer I/II program updates were approved by the Curriculum Committee and will be presented to the full Commission in February.
- > The preliminary draft of the NFPA 1001, FF I/II, Curriculum Review Report was submitted to the Curriculum Committee and we are working on the final version.

Special Projects

➤ In an effort to better serve you, the Division is implementing a new initiative to develop a 9 to 12 month training calendar so departments and prospective students can better plan their future training opportunities. The Academy has established two semesters of training moving forward, a spring and fall training semester. Twice a year we will actively solicit training requests which will be taken into consideration during the future course planning process. Additionally,

you may submit training request at any time throughout the year which will be considered during the next planning period.

- At this time we are seeking requests for training programs that would be scheduled between July 1, 2022 and June 30, 2023. Our goal is to announce all scheduled training programs for this timeframe by May 1, 2022. We will be collecting requests for this time period through February 28, 2022. You can submit your request at https://nhfa-ems.com/training-request/.
- Commissioner Quinn and Director Cutting met with Chancellor Mark Rubenstein and some of his staff from the Community College System of NH to discuss methods of collaboration and potential areas of partnership.
- ➤ Additional drilling for PFAS monitoring wells throughout the Concord campus is planned.
- ➤ We participated in a meeting with NHAFC, PFFNH, FMO, FSTEMS and the State Firefighters Association on December 16th at the academy.
- ➤ We are nearing completion of realigning and restructuring the geographical areas of the state that our (field) Fire Captain's cover and will communicate those when the final open Captain position is filled.

Legislative/Administrative Rules

- > We are monitoring a number of bills in the legislature. A few that we want to highlight are:
 - SB 357, relative to Mental Health Training for First Responders.
 - SB 339, relative to Meetings of Boards and Commissions in the Department of Safety.
 - SB 337, relative to Emergency Medical and Trauma Services Data sharing for the purposes of analysis.
- ➤ The "Letter of Concern" option for EMS licensure actions that was passed in 2021 legislation is being worked on through the administrative rules process.

Outreach

➤ We are continuing our Leadership Roundtables with the Fire Marshal's Office and regional Fire Chief's with dates planned in January.

Mental Health & Resiliency

- ➤ We are waiting for notification on whether our American Rescue Plan Act grant request through the Health Resources and Services Administration officials has been approved or not to address suicide, burnout and behavioral health conditions including substance abuse among public safety officials.
- ➤ We continue our meetings with mental health professionals to develop a spring 2022 seminar with Fire Chief's, Police Chief's, labor leaders and clinicians to provide professional development, continuing education and a networking opportunity.
- ➤ We are working with the National Fallen Firefighters Foundation to host trainthe-trainer programs here in NH for some of their firefighter behavioral health courses, including stress management and mental health for responders.

BUREAU OF FIRE TRAINING

Courses/Programs

- ➤ Firefighter I classes
 - The Bartlett class is scheduled for testing later this month.
 - o Plaistow and Henniker classes begin this month.
 - o The Burton Facility, Bethlehem class, begins early February.
- > Firefighter II classes
 - o The LRCC class begins this month.
 - o The Tilton class begins this month.
- ➤ Beginning February of 2022, to be eligible to take the required skills or knowledge tests, commercial driver's license applicants must have completed applicable entry-level driver training from a registered training provider. This is a federal requirement.
 - We are working with NH DMV with the goal of becoming one of those providers.

 Legislation is being promulgated to exempt state and local agencies that provide this training from certain requirements in the RSA's.

Facilities

➤ We are awaiting work to begin on the roadway washout on the south side of the drill yard at the Concord campus.

Apparatus/Equipment

- Committees for construction of the new ARFF truck and Engine continue to make progress.
- Completion of the new aerial is still expected next year.

BUREAU OF CERTIFICATION AND SUPPORT

Courses/Programs

- ➤ Instructor I/II/III Programs
 - Instructor I began January 10th.
 - There will be a Saturday offering of Instructor I at the Burton Training Facility beginning March 12th.
 - We are exploring sites in the Upper Valley for an additional Instructor I class in the spring.
 - The first Instructor II/III course in 2022 will begin February 20th.
- ➤ Fire Officer I/II Programs
 - The next Fire Officer I course begins January 20th.
 - The next Fire Officer II course begins March 24th.
- > Fire Inspector Programs
 - The Warrants and Citations course will be held December 8th & 9th.
 - Fire Inspector I class began January 11th.
 - The next Fire Inspector II class begins April 5th.
- ➤ Fire Investigator
 - The next offering will begin August 25, 2022.

➤ We continue to work the Instructor Recruitment Plan. Recruiting more, new, instructors remains a top priority for our Division.

CPAT

➤ The 2022 CPAT dates are planned for April 18th, May 23rd, June 6th &7th and September is TBD.

Testing

➤ With the award of the AFG grant we continue to work with the DOS IT group to develop the RFP to replace the current certification testing software.

BUREAU OF EMERGENCY MEDICAL SERVICES

Boards and Commissions

- ➤ The NH Medical Control Board and the NH Emergency Medical and Trauma Services Coordinating Board meetings will take place at 0900 and 1300, respectively, on January 20th in classrooms 5 & 6 in the dormitory building.
- ➤ The NH Trauma Medical Review Committee (TMRC) will meet at 0930 on February 17th in classroom 2 in the administration building.

Operations

- ➤ 283 EMS Unit licenses were issued in December.
 - 250 of those applications (88%) were created and submitted by the services externally through the public portal.
- ➤ EMS provider renewals will be available in RespondNH this spring.
 - o As of January 12th there are 5,552 licensed EMS providers in NH.
- ➤ EMR classes in 2022 the first begins January 19th, delivered primarily through a hybrid format of live streaming classroom sessions and in-person skills training.
 - We have waitlists at the Bethlehem and Concord campuses.
- > Our EMS Education Coordinator continues the monthly continuing education courses at the Concord campus and regionally around the State.

- ➤ We are working with Board of Nursing as a Subject Matter Expert for consideration of the following:

Clinical Systems

- ➤ Patient Care Protocol updates and corrections (8.1 Mid Cycle Roll-out) were approved by the Medical Control Board on November 18th.
 - The sixty-day opened on December 17th and in-person public comment will be available January 27th from 12-3p at the NH Fire Academy in Classroom 1.
- ➤ On December 21st the "State of New Hampshire Emergency Protocol COVID19 Destination Determination v.3" was reinstated to assist units in their COVID-19 response regarding destination determination and the transport decision of suspected COVID patients. Additionally, the "State of New Hampshire Emergency Protocol COVID19 v.6" was updated to include additional personal protective equipment required by providers when caring for a patient with suspected or confirmed COVID and/or in the performance of high level or aerosol generating procedures.
- > Covid-19 protocols and the "public health incident" are still in place allowing for 1 EMS provider in a transporting ambulance if staffing is low.

NH Fire Standards and Training Commission – (Chiefs Clark/Buxton)

The Commission last met on November 3, 2021 and is scheduled to meet February 3rd. The January 6th meeting was pushed back to allow staff sufficient time to prepare for the meeting. There are several new members on the Commission and the membership on the various standing committees will be revised.

The Curriculum Committee held a 3 ½ hour meeting on January 6th to deal with a very busy agenda. 





Thank you for your participation. I know that Doug will appreciate it.

- We will be moving forward to fill the Captain vacancy. As this will take time, we know we will be entering the spring fire season with 50% reduced ranger staffing. Out of our 10 Forest Ranger positions, we will have 3 rangers in the police academy through April, 1 ranger position continues to remain unfunded, and the 1 vacancy we are in the process of filling, which leaves 5 rangers in the field. We will have our wildfire patrols and Special Deputy Forest Fire Wardens available to assist as well. If you need assistance, do not hesitate to call us.
- Legislation We are preparing our opposition of HB 1555 Titled "Repealing the permit requirement for fires at campgrounds". While the bill title suggests it will only repeal the permit requirement for campgrounds, the actual language of HB 1555 will repeal the permit requirement for all Category I and II fires. This means that there will be no state or local oversight of category I and II fires and limited opportunity to regulate burning during high fire danger or interact with citizens and visitors for wildfire prevention purposes, all of which we expect will increase wildfire occurrence and suppression costs for the state and municipalities. For this reason, the Division of Forests and Lands will be opposing HB 1555. The complete text of HB 1555 is included at the end of this report.
- The Online Fire Permit program was updated in 2021 and had a bug fix in December. The system has proven very effective and useful over the past 2 years, which is shown by the marked increase in permits obtained. We will have new training guides later this winter and will review the system functions during the spring warden trainings.







• We are in the process of hiring part time positions to staff the fire towers every Saturday and Sunday from 11:00am to 5:00 pm, April through October. Staffing the fire towers on a regular basis has been a goal of the division, and we have managed to secure funding to staff the weekends. We will still staff on weekdays when the fire danger is high, but this additional funding will allow us to reach out to more visitors and provide better maintenance to our facilities, while providing detection during the weekends. If you know of someone who may be interested, please ask them to reach out to you forest ranger for more information.

STATE OF NEW HAMPSHIRE

In the Year of Our Lord Two Thousand Twenty Two

AN ACT repealing the permit required for fires at campgrounds.

Be it Enacted by the Senate and House of Representatives in General Court convened:

1 Woodland Fire Control; Permits; Damages; Penalties. Amend RSA 227-L:17, IV to read as follows: IV. Camp or cooking fires may be kindled only with written permission of the landowner or the landowner's agent [and written permission of the forest fire warden of the town in which the fire is to be kindled] and only at suitable times and in suitable places when the fire will not endanger woodlands; except in such towns as have adopted bylaws or regulations equally as stringent as provided in this paragraph. Camp or cooking fires may be built without written permission on public camp or picnic grounds when such areas are open for public use or private camp and picnic places where suitable fireplaces approved by the forest fire warden are provided for such fires. As used in this paragraph, a camp or cooking fire shall be a small fire suitable for cooking purposes used in connection with camp, picnic or lunch purposes and does not include the burning of household rubbish, or large amounts of brush or other flammable material. Whoever shall kindle or cause to be kindled any such fire or use an abandoned fire in or near woodlands shall totally extinguish the same before leaving it and, upon failure to do so, such person or persons shall be subject to the same liabilities and penalties as prescribed in this section.

- 2 Repeal. RSA 216-I:9, V, requiring recreational campground or camping park owners to obtain a fire permit, is repealed.
- 3 Effective Date. This act shall take effect 60 days after its passage.

METHODOLOGY:

The Department of Natural and Cultural Resources states this bill would eliminate the requirement of a permit for all camping and cooking fires, which would require the reprinting of fire permits, brochures, posters, and other materials to reflect the law change. The Department estimates this would cost approximately \$11,100. It is assumed since this bill is effective 60 days after passage, expenditures would be incurred in FY 2022. There will be no impact on county and local revenue or expenditures.
