## Minutes of a Meeting of the NH Association of Fire Chiefs

Thursday, March 9, 2023 - NH Fire Academy, Concord, NH

The meeting was called to order at 0914 hours by Chief Best.

After a salute to the flag, a moment of silence was requested for departed members.

Director Cutting welcomed all to the Academy.

James Heinz, Fire/EMS Liaison Officer for the NHIAC spoke to the members about Operation Flashpoint (bombmaking materials) which is being rolled out. He also wanted to share more information about the NHIAC and stated that they have prepared a program to share on the subject.

President's Report: (Best) –

• **Nominations Committee** (Jay Lyons) - looking to fill Mike McQuillen's position, others are interested in continuing on the BOD positions as planned.

• Mike Sitar is interested in serving as the past president, Kirk Beattie has stepped down due to conflict of interest with his new position.

#### House Bill 436 (Pension Reform Bill)

Division 1 of House Finance held a work session on HB 436. The sponsors explained the intent to eliminate the "middle tier" in Group II and the funding mechanism to allow for that to happen (\$25 million per year in general funds, for 10 years). The House recently approved the policy and the focus of the work session was to review the financial impact.

Division members had a number of questions regarding the impacts on the retirement system of the proposed revisions to benefits. Generally, there were concerns that even after the 2011 changes, the shortfall in the retirement system has grown from \$2 billion to over \$5 billion. Supporters acknowledged that was true, but countered by highlighting the total amount of holdings by the system is over \$11 billion and the percentage of funded liabilities has improved. In addition, there were questions regarding the impacts on municipalities required contributions.

After about an hour of discussion, the Division voted 9-0 to retain the bill. Prior to the vote, several committee members indicated that the Finance Committee could attempt to implement the funding and the statutory change as part of the budget. It was not clear if there was consensus on that suggestion. The full committee will vote on the recommendation to retain the bill later this month

1200 fire department employees would be impacted. The goal is to retain employees that have between 10-19 years of service in the system.

• HB 647 immunity. The NHAFC has sent a note opposing the bill but supporting the amendment in committee to kill it.

## Executive Director's Report (Lemire) -

- We will be having our Annual Meeting and celebration of the association's 90<sup>th</sup> birthday at the Common Man Inn and Spa in Plymouth. It is the intention to have members invite spouses/guests for this meeting and dinner. We have minted a challenge coin for member attendees of the dinner/meeting. More info to follow.
- The board has decided that, due to the changed nature of the Primex conference this year, we will not be having our May meeting in Portsmouth. It will be on May 11, the regularly scheduled day at the Fire Academy again for breakfast.
- The June meeting is scheduled for Brookline with Chief Corey and gang cooking an old fashioned roast beef dinner.

## NHAFC LEGISLATIVE UPDATE - February 9

An updated legislative chart was distributed via email to all members. If you have questions about a bill, reach out to us, and we can either answer or get information from our lobbyist. There is a lot going on at the State House this time of year.

- **HB 373 (ambulance billing)** NHAFC opposed the bill with testimony at a recent hearing. The House Commerce Committee voted to retain the bill last month. The Committee will be able to work on the issue this summer and fall. This is a positive development.
- **SB 153** (**first responder program**) NHAFC supported the bill. It is intended to create a program to help with career development, recruitment, and retention of first responders. The Senate committee voted to re-refer the legislation. The Senate will vote on their recommendation during their session next week.
- **HB 647 (qualified immunity)** NHAFC opposed the bill as it could create liability concerns for municipalities and their workforce. The House Judiciary Committee voted 16-3 to kill the bill. It will head to the House floor late today. There is expected to be an attempt to either overturn the committee report or sent it back to committee. NHAFC prepared a letter outlining support for the committee recommendation to kill the bill.
- SB 71 (Workers' Compensation for Firefighters with Cancer/Committee to Study Annual Cancer Screening) NHAFC supported the bill and it has passed the Senate. NHAFC will have a member on a commission to study annual cancer screenings for firefighters, should the bill become law. We plan to speak in favor of the bill once it is heard in the House.
- **HB 296 (Driveway permits)** NHAFC opposed the bill as introduced since it bill proposed that the "...state fire code and associated rules shall not supersede the authority of local land use boards under planning and zoning provisions..." as it applied to driveway permits. The House Public Works and Highways Committee passed the bill with an amendment which narrowed the focus for detached residential one or two family dwelling units. The amendment would require a "minimum driveway width shall not be less than 12 feet for driveway over 150 feet in length." The House will vote on the bill during a session later this month. If passed, it will go to the Senate.
- **HB 436 (Group II Revisions)** Generally, the intent of the bill is to eliminate the "middle tier" of Group II members (those who were members of Group II but not vested by 1/1/12). The bill would phase in benefits for those in the middle tier over the course of 10 years. It passed the House earlier this month. After it passed on the House floor, it was referred to the House Finance Committee to

consider the financial impact. NHAFC sent a letter to the Finance Committee in support of the bill. A committee vote will occur later this month.

- At the Executive Council meeting on March 8, 2023, Governor Sununu renominated Commissioner Quinn, Assistance Commissioner Edwards, and nominated Steve Lavoie to replace retiring Assistant Commissioner Bailey. The Council will likely vote on the nominations at a subsequent meeting.
- NH HSEM Homeland Security Grant Review Committee He spoke about NH HSEM grant review committee which met on March 1, 2023 at the Department of Safety. The review committee recommended to the Commissioner of Safety that all the applications that met the grant requirements for funding and also received passing scores from the committee be funded. The committee also recommended that surplus grant monies be allocated to hazmat and active threat training across the State.

## Legislation:

The 2023 session is just getting started. Below are some of the bills and LSR's that we are watching:

HB 265 relative to municipal property tax relief for installation of fire suppression systems

Status: ITL

HB 296 relative to local authority for granting driveway permits

Status: Passed House Committee (removes FD ability to regulate access for 1 & 2 family homes)

HB 564 relative to ratification of amendments to the state building code and state fire code

Status: Passed House with Amendment

SB 170 relative to small group child day care centers

Status: Passed Senate with Amendment

#### **Board of Fire Control:**

The Board of Fire Control and the SFMO staff have started the review of the 2021 editions of NFPA 1 and NFPA 101. The goal is to have a package ready for legislative action in 2024.

#### Foam Take-back Program:

We continue to work with DES to launch the foam take-back program. Due to contracting and permitting challenges the launch of this program is delayed into 2023. An important consideration in the program is the best and safest disposal methods to destroy the PFAS chemicals. The latest inventory is approximately 9,600 gallons. We need to identify a collection point in each county for foam collection, please send an email to fmo@dos.nh.gov if you are interested.

#### **BUREAU OF INVESTIGATIONS:**

In the month of February, we received 15 incident notifications resulting in 5 scene responses. The Bureau of Investigations currently has 11 open arson or suspected arson investigations.

## <u>New/Active cases (synopsis of some of our cases are listed below):</u>

- On February 3, investigators responded to a structure fire in Claremont in which people reported seeing a person throw something at the building. The fire started inside the building and the cause is under investigation at this time.
- On February 5, investigators responded to a structure fire in Rochester.
   The cause appears to have been accidental but is still under investigation.
- On February 10, investigators responded to a roof collapse in Bennington. High winds caused the roof of a building under construction to fall, injuring two workers.
- On February 21, investigators responded to a motor vehicle fire in Hill.
   A truck that had fled police earlier in the day had been found burning on a Class VI road that evening. Arson is suspected, but the cause is still under investigation.
- On February 22, investigators responded to a structure fire in Meredith, believed to have been caused by a dryer.

## Ignitable Liquid Detection Canine Teams:

 An IGL canine team performed a demonstration at the Concord Regional Technical Center to their firefighting, law enforcement and medical programs.

We initiated 10 educational and 3 healthcare plan reviews, completed 107 inspections and 108 technical consults in the month of February.

#### **Hazardous Materials:**

Hazardous Materials response, coordination and consultation is available through the on-call FMO

supervisor. Our Hazardous Materials Coordinator is available for PEAC Software training for fire

departments. PEAC is used for documentation of Tier II facilities and chemical storage.

In the month of February, our Hazardous Materials Coordinator attended the Hazardous Materials Collaborative meeting. He also provided training to the Southeastern NH Haz Mat Team on the use of PEAC software for chemical facility research and incident management. He continued working with the Regional Haz Mat Teams and HSEM on planning a Wide Area Air Monitoring Exercise for the spring of 2023.

Received 345 Tier II reports for New Hampshire facilities.

Responded to 112 questions from facilities regarding Tier II reporting.

Further discussions and work are ongoing to evaluate the hazmat problem and funding sources.

## Swiftwater Rescue Working Group:

Further discussions and work is ongoing to evaluate the swiftwater problem and funding sources.

## Regional Outreach/Chief's Roundtables:

We continue to partner with the Commissioner's Office, Director Cutting and the NHAFC to conduct regional outreach/Chief's Roundtables. An Ossipee Area Roundtable is being held on March 20<sup>th</sup> at 6:30 pm at the Tuftonboro Central Fire Station.

## <u>Fire Standards/Training/EMS</u> – (Director Cutting) ADMINISTRATION

#### Personnel

- ➤ We continue to recruit and interview for our open full-time Fire Service Instructor Supervisor (Captain) positions.
- ➤ We have made an offer to a candidate for our Curriculum Administrator position with a March 24<sup>th</sup> planned start date.
- > Our part-time Program Coordinator positions for Fire Instructor, Hazardous Materials, Swift Water and EMS Initial Program are open and we are seeking applicants.
- ➤ Bill Campbell has been hired as the Fire Officer Program Coordinator.
- ➤ Captain Christopher Rousseau has submitted his retirement after 17 years of service. Captain Rousseau has been instrumental in many different aspects of the Division. Most notably however is the development and creation of the

Educational Technology section. He has established the Division as one of the leaders in New Hampshire with the development of online education in which other organizations have utilized us as a resource or have requested us to develop their own training programs. We wish Captain Rousseau with best in his future endeavors.

#### **Grants**

- ➤ We continue to work with the architectural firm on the design process for the Raymond S. Burton Fire and EMS Training Facility project.
  - We are working with all parties to overcome the challenge of significant price increases in construction costs over the last year.
- ➤ We have submitted our application for the 2022 AFG Program.
- ➤ All grant funded Technical Rescue and EMS in the Warm Zone training programs that are eligible for overtime and backfill will require us to change our registration process, more specifically closing registration earlier than we have historically so we can process all necessary paperwork. Grants agreements now need to be in place with local agencies prior to the training program and will require approval from Governor and the Executive Council to be reimbursed.
- ➤ We are working with the Department of Health and Human Services Covid Disparities Funding program to expand Image Trend to add Continuum, additional IFT, MIH and simulation training and staff support.

## Fire Standards and Training Commission / Curriculum

- ➤ The next Fire Standards and Training Commission meeting will be May 4<sup>th</sup> at 0930 in Classrooms 5/6 in the dormitory building at the main campus. The full schedule for 2023 also includes meetings on September 7<sup>th</sup> and November 2<sup>nd</sup>.
  - The Visiting Committee's for the development of a Fire Officer III & IV program and the Technical Rescue Program Rope Operations and Technician continue their work.
  - The Commission voted to establish a Visiting Committee for the Fire Investigator Program and is seeking interested individuals.
  - The Administrative Rules Sub-Committee has re-convened and will be evaluating the Fire rules relative to the Recruitment and Retention report and their recommendations as their first priority. Additional meetings were held on March 8<sup>th</sup> and planned for April 12<sup>th</sup>.

## Special Projects

➤ We are now registered with NH Works which will provide grant funding to train non-affiliated individuals seeking training at the Fire Academy for Firefighter I, Firefighter II and CPAT.

➤ Our Division and New Hampshire Employment Security have finalized the details on the New Hampshire Emergency Medical Technician Training Program using the \$2,535,030 in American Rescue Plan Act (ARPA) Funds that were approved.

#### **Facilities**

- ➤ We are working on "B" building upgrades.
- ➤ We continue to work with NH Public Works on getting the design and engineering complete to repair the roadway washout on the south side of the drill yard at the Concord campus. An engineering firm has been hired to design the reconstruction. We have received our wetlands permit and will be reviewing estimates for repair costs.
- ➤ We are working on the replacement of two AC condenser units in the dormitory building.

#### *Legislative/Administrative Rules*

- ➤ The new legislative session has begun, and we are tracking a number of bills this year. A few include:
  - HB 183 Relative to Employment of Retired Firefighters at the Fire Academy
  - SB 153 relative to establishing a First Responder Career Development,

- ➤ We continue our work in partnership with the Police Academy to develop a more comprehensive program for PTSD training utilizing experts from this field in development of the curriculum.

## <u>Clinical Systems</u>

➤ Work continues on EMS Protocols Ver. 9.0.

➤ The Public Health Incident declared by Acting Commissioner Weaver of NH Department of Health and Human Services has been extended to March 31, 2023.

The extension of the Public Health Incident allows for the continuation of all Emergency Protocols and any modifications to ambulance staffing requirements. These include:

- Emergency Protocol COVID-19
- Emergency Protocol COVID-19 Testing
- Emergency Protocol COVID-19 Immunization
- Emergency Protocol Personal Protective Equipment (PPE)
- Emergency Protocol COVID-19 Temporary Mobile Integrated Healthcare (MIH)
- Staffing modifications under Saf-C 5902.06 (m), as it relates to a public health or safety incident declared in writing to the governor by the commissioner of the department of safety or the commissioner of the department of health and human services.
- We are continually reviewing these Emergency Protocols for their effectiveness on the delivery of patient care as well as well as their necessity in day-to-day operations within this evolving environment.
- ➤ The development of Trauma Rules is still underway and making progress.
- ➤ We continue our outreach and support to agencies for inter-facility transfers and mobile integrated health programs.

#### Data Management

- Reporting
  - We've added a new folder to ELITE report writer called **Grant Data Templates**. Several of the templates are preset to run totals for the years 2020-2022 as required for the current AFG grant request. So far, we've built the following report templates for services to copy and customize:
    - Total Calls by Incident Type Category for years 2020-2022
    - Total Calls by Incident Type Code for years 2020-2022
    - Mutual Aid Given/Received for years 2020-2022
    - Mutual Aid Given/Received Structure Fires only (NFIRS 111-123) for years 2020-2022
    - EMS Runs by Patient Disposition 2020-2022
  - These reports can work for most grant as they all ask for similar information. We've included instructions in the description area explaining how to change the time period on the filter tab.
  - We have also built reports for services to extract run data for the CMS data reporting requirements that CMS requires of transporting EMS services. Each year over a 3-year period CMS assigns different services to report a large amount of data with the intent of determining the actual cost of delivering EMS care. Most of the data comes from financial records, but some of it comes from run records. They all start with "CMS" with the rest

of the label including the specific question number from the data collection guide.

## ➤ NFIRS/Respond NH

- Work continues on the New Hampshire Emergency Services Reporting System (NHESR), which is an extension of the TEMSIS system. If you would like to start using the system, please fill out the form available at <a href="https://nhfa-ems.com/nhesronboard/">https://nhfa-ems.com/nhesronboard/</a>.
- Our next fire reporting user group is scheduled for Wednesday March 8<sup>th</sup> at 1300 hrs. All departments who utilize hours tracking within this system for payroll purposes are recommended to attend or send a representative to this meeting. A recording of this meeting will be emailed after the meeting if you are unable to attend.
- There are 14 departments in the onboarding process, and 3 awaiting onboarding, for this software and many are using it.
- Coordination continues with the Fire Marshal's Office for further education and guidance for reporting.

## > RespondNH

- The Division continues to expand the capabilities of the RespondNH system. As we are able to utilize this system and analyze more data it is important to have department roster information updated and current. Each department has the full capability to manage their own roster by adding new staff and removing those that may have left. Departments are able to do this at any time. For State level reporting information please fill out your roster information to include their status (career, call, or volunteer) as well as the duties they provide such as EMS care and/or fire suppression.



## IAFC Director – (Chief Christopoulos) – (Report submitted in writing)

#### AFG AND SAFER

On Wednesday, March 8, the U.S. Senate's Committee on Homeland Security and Governmental Affairs will consider legislation to reauthorize funding for the Assistance

to Firefighters Grant (AFG) program (popularly known as the "FIRE grants"); the Staffing for Adequate Fire and Emergency Response (SAFER) grant program; and the U.S. Fire Administration (USFA).

Currently, the AFG and SAFER programs are scheduled to expire on September 30, 2024. The Fire Grants and Safety Act (S. 559) would protect these programs. The bipartisan legislation would:

- Extend the authorization of funding for the AFG, SAFER and USFA programs through Fiscal Year (FY) 2030.
- Increased the authorization for the USFA to \$95 million.
  - USFA was authorized at \$76.49 million in FY 2023, so that's an almost \$20 million increase.
- Extended the sunset for the AFG and SAFER programs to September 30, 2032.

S. 559 was sponsored by Senators Gary Peters (D-MI); Susan Collins (R-ME); Lisa Murkowski (R-AK); and Tom Carper (D-DE).

The AFG and SAFER programs provide critical matching grants to local fire departments for training, equipment, and staffing. The grant funds are awarded using a peer-review process that includes input from fire and emergency service personnel across the nation. The USFA hosts the National Fire Academy, the nation's premier fire service educational institution.

Please ask your Senators to pass S. 559.
