Minutes of a Meeting of the NH Association of Fire Chiefs

Thursday, July 11, 2024 – NH Fire Academy

The meeting was called to order by Chief Watkins at 0925 hours.

After a salute to the flag, a moment of silence was requested for departed members.

Welcome from Host: Director Cutting welcomed everyone to the meeting.

INTRODUCTION OF MEMBERS. Members were asked to introduce themselves and state where they were from.

Special Guests: Commissioner Quinn was introduced and welcomed everyone.

Minutes: A MOTION (Sitar/Paquette) to approve the minutes of the June meeting, carried unanimously.

Treasurer's Report: A MOTION (Fraitzl/Tremblay) to approve the financial reports from June, carried unanimously.

Applications for membership: Asst. Chief Greg Laro of the Derry Fire Department has been approved for membership.

President's Report: (Emanuel) – (Submitted in writing for minutes)

He reported that he represented that NHAFC at the NH Safety Leadership meeting (Five Families) on June 28th with the key players from PFFNH, NHFMO, NH HSEM, and NHFA. The group discussed various legislative issues and impacts on the NH Fire Service.

He will be attending and speaking at a National Fallen Firefighter Foundation program in Detroit, MI and unable to attend the NHAFC July meeting at the NHFA.

The NH Fire Explorer Academy was a success and were grateful for the NHAFC financial contribution to support the program.

Thank you, Chief Scott Hunter, for attending the governor's bill signing ceremony for the cancer legislation in Manchester last week.

He will be attending the IAFC Fire Rescue International program in Dallas in August.

Report of the Executive Director: (Lemire)

- Our August 7 BOD meeting will be Virtual.
- On August 8, we'll join our North Country brethren at the Town and Country in Gorham (Shelburne) where we'll have a seminar developed by the Professional Development Committee entitled "How to Promote Effective Community Risk Reduction" presented by Jason Smedick of the Merrimack Fire Department.
- August 12 will be the Golf Tournament at Lochmere in Tilton.
- Our application for 501 c3 has been submitted to the IRS and the fee paid! We have found out that it may take 191 days for action.
- Ad book proceeds to date: Total: \$24,450; Vendor: \$17,115; Assn: \$7,335
- Finally, several of you have asked about another November Professional Enhancement Weekend. It's a GO! I have a proposal from the "Snowy Owl Inn" at Waterville Valley for November 15-17. The Professional Development Committee has proposed a subject for the morning seminar on Saturday with the monthly NHAFC meeting being held at 1:00 that afternoon.

1st Vice President Report (Watkins) - no report

Government Relations – (Schmidt) – (submitted in writing)

The New Hampshire House and Senate have completed their work for the 2024 regular session. The chart includes all the bills we followed for the NH Association of Fire Chiefs. The bill numbers provide a link to the text of each bill. At this point, a number of bills have passed the Legislature, but have not yet been acted upon by the Governor. You will note that some bills were sent to "Interim Study". Interim Study means that the bills will not move forward in the 2024 session. House policy committees will meet in the late summer and fall to further examine these bills. By Friday, October 25, House Committees must issue non-binding recommendations whether similar legislation should be re-introduced in 2025. There will be a calendar issued in the fall with written reports detailing the recommendations. The Senate will likely use a far less formal process.

For legislation in 2025, the House has set the initial filing period for incumbents running for re-election in the 2024 election for September 3 through September 13. There will be another filing period after the election from November 6

through November 22. The Senate will set deadlines for filing legislation for 2025 at a later date. Governor Sununu has vetoed several bills thus far. A veto session day will likely be scheduled for the fall at which time the House and Senate will vote whether to override the vetoes or not.

There were several updates on key issues we wanted to provide:

HB 1081 (Direct Pay for Ambulance Services) - Governor Sununu recently signed the bill into law. It will go into effect in early September. The law will require private health insurance carriers to pay ambulance providers directly, regardless of whether or not they are in network.

SB 352 (Retired and Full Time Firefighter Cancer Screening Program) – Governor Sununu signed the bill into law last week. It creates a \$5 million fund from which re-imbursements to retired and full-time fight fighters could seek re-imbursement when specific documentation is provided. NHAFC, PPFNH, and Fire Standards and Training would be responsible for development of an initial plan to implement the screenings. The plan would be submitted to the Governor and Commissioner of the Department of Safety.

NH DOI Ambulance Cost RFP – As a follow up from SB 407 earlier this year, the NH Department of Insurance recently issued an RFP which stated goal is "....Completion of a New Hampshire ground ambulance cost study and development of an illustrative, cost-based default reimbursement rate schedule for ground ambulance services in the state." Proposals from interested potential vendors are due by July 23 with a potential selection by July 26. The RFP states that selected vendor would be expected to start their efforts after SB 407 is signed by Governor Sununu. The results of the study would serve as the basis for legislation in 2025 that would "...prohibit ground ambulance balance billing and set a universal default rate schedule at least for all commercial, fully-insured payers and that would be sufficient to cover the costs of ground ambulance services if all payers (public and commercial included) used that same reimbursement rate schedule. The schedule is considered a default schedule because it is envisioned that providers and payers would still be free to contract for different rates with the default rates applying only when services are provided by an out of network provider. The illustrative, default rate schedule should be so designed that, with little modification, it could be used by the state in support of a federal waiver to establish an All-Payer Model Agreement under §1115A of the Social Security Act to implement an all-payer model system for reimbursing ground ambulance services in the state. It should also be so designed that it could be compared to the current Medicare fee schedule." Once a vendor is selected the RFP includes suggestions regarding a stakeholder working group and efforts to collect information. NHAFC may be approached about participating in the process.

<u>Board of Fire Control:</u>

The next Board of Fire Control meeting is scheduled for September 18, 2024. The Board will be reviewing fire protection requirements for summer camp program bunkhouses.

<u>Foam Take-back Program:</u>

The collection of foam will take place in August 2024. Surveys have been sent out to obtain accurate inventory and identify collection points throughout the state. It is critical to take part in this program to properly dispose of PFAS containing foam. This will be a single opportunity under this program. This program is being led by NH Department of Environmental Services. We can assist with any questions.

BUREAU OF INVESTIGATIONS:

In the month of June, we received 16 incident notifications resulting in 10 scene responses. The Bureau of Investigations currently has 13 open arson or suspected arson investigations.

<u>New cases (synopsis of some of our cases are listed below):</u>

• On June 4, investigators responded to Bradford for a fire in a house that was under construction. The investigation is ongoing with the

Bradford Fire Department.


- On June 8, investigators responded to Springfield to assist with an investigation of a fire in an industrial building. It appears the fire is accidental.
- On June 12, an investigator responded to Claremont to assist the Claremont Fire Department with a fire investigation of items that were on the lawn in front of a house. It was determined that the use of fireworks had accidentally set the fire.
- On June 21, investigators responded to Franconia to assist the Franconia Fire Department with an origin and cause investigation. The cause of the fire is suspected to be electrical.
- On June 29, an investigator responded to Claremont to assist the Claremont Fire and Police Departments with the investigation of a mobile home fire. The cause of the fire is undetermined at this time, although an electrical issue is suspected.

<u>Fatal Fire/CO Incidents:</u>

- On June 4, investigators and a K9 team responded to Weare for a house fire. One deceased male victim was found at the scene. The cause of his death was ruled to be unrelated to the fire.
- On June 6, investigators and a K9 team responded to Charlestown for a mobile home fire. Two deceased victims were located inside the mobile home. The fire is still under investigation and does not appear to be criminal in nature. The cause of death of both victims was smoke inhalation and the manner of their deaths was accidental.
- On June 16, investigators responded to Dover for a fire involving a tabletop fire pit fueled with isopropyl alcohol, where three individuals sustained burn injuries. Several days later, the SFMO was notified that two of the individuals had succumbed to their injuries.
- On June 17, investigators responded to Goffstown for a house fire. One deceased male victim was found inside the house. The fire is still under investigation and does not appear to be criminal in nature. The cause of the victim's death was smoke inhalation, and the manner of death was accidental.
- On June 19, investigators responded to Epping for a garage fire. One deceased male victim was found inside the garage. The cause of his death was ruled to be unrelated to the fire. The cause of the fire is still under investigation.
- On June 26, the Concord Police and Fire Departments responded to an incident in their city where a deceased male was found inside a vehicle. Also found inside the vehicle were bottles of formic acid and sulfuric acid. Mixing these two chemicals generates carbon monoxide. The victim's cause of death was ruled carbon monoxide poisoning and the manner of

his death was ruled a suicide.

Fatal fires are tracking ahead of the past two years. We recently issued a <u>press</u> release to raise awareness of the trend, along with an infographic that displays mid-year 2024 statistics as of June 26, 2024.

To enhance fire safety and reduce fatalities, the New Hampshire State Fire Marshal's Office recommends the following:

- Install smoke alarms inside each bedroom, outside each sleeping area and on every level of the home, including the basement.
- Components of the alarms will deteriorate over time and can only be expected to work effectively within 10 years of their date of manufacture. Replace smoke alarms that are older than 10 years.
- Interconnected alarms are best. Wireless is an acceptable option.
- Hard-wired smoke alarms should have battery back-up in case there is a power outage.
- Battery powered smoke alarms should be changed twice a year. A 10-year sealed battery is preferred.
- Test smoke alarms monthly to ensure they are functioning properly.

Youth Firesetter:

- There were 3 youth firesetter assessments in the month of June.
- The SFMO had 4 additional youth firesetter inquiries.
- Three agencies were provided youth firesetter training.

<u>Training/Committees:</u>

- Two BOI members attended a Fire Death/Arson Investigation Seminar in Bucksport, ME.
- Two BOI members attended the Youth Firesetting Prevention and Intervention program at the National Fire Academy in Emmitsburg, MD. While they were there, they also attended the Three State Weekend which is attended by fire department members from New Hampshire, Vermont, and Alabama. Our members took leadership classes.
- Deputy Fire Marshal Fanjoy attended a week-long Internal Affairs Investigation class held at NH Police Standards and Training.

BUREAU OF BUILDING SAFETY & CONSTRUCTION:

SB 599 relative to the State Fire Code was signed into law by Governor Sununu. The 2021 edition of NFPA 1 and NFPA 101 will be effective August 13, 2024. Training class information can be found later in this report.

<u>Hazardous Materials:</u>

Hazardous Materials response, coordination and consultation is available through the on-call

SFMO supervisor.

Our Hazardous Materials Coordinator is available for PEAC Software training for fire departments. PEAC is used for documentation of Tier II facilities and chemical storage.

In the month of June, our Hazardous Materials Coordinator attended the IAFC Hazardous Materials Response Teams Conference, a training to mitigate propane emergencies by the Propane Gas Association of New England, and a training on our new FTIR Portable Gas Identifier. He also attended the quarterly meeting of the Advisory Council on Security and Emergency Preparedness, the Haz Mat Collaborative monthly meeting, the monthly PEAC training and the Ossipee Valley Mutual Aid Association meeting.

Our Hazardous Materials Coordinator conducted phone consultations with regional teams for two hazardous materials incidents in the month of June.

Electric Vehicles and Lithium-Ion Batteries

This first meeting of the study counsel established by SB 430 will be held at the IPOC on July 17, 2024. The intent of this counsel is to study the impacts of electric vehicles, e-mobility devices, and the associated lithium-ion batteries hazards for first responder response, the environment, building and fire codes, life safety, and property protection.

<u>Personnel</u>

- We have made a conditional offer to a candidate for the Fire Service Instructor Supervisor position (Captain) in the Bureau of Certification and Support.
- We have one vacancy for Program Specialist III (Education Technologist) of the Educational Technology section.

- We have had final interviews with three candidates for the Emergency Services Records Management Coordinator position.

<u>Grants</u>

- > The Raymond S. Burton Fire and EMS Training Facility infrastructure project continues to move forward. The contract with the selected vendor is complete with construction on phase I expected this Summer.
 - Construction documents are being developed for eventual requests for proposals for Phase II.
- > Our 2023 AFG grant submission is pending.
- The NH EMT Training Program remains active with grant funding for training new and existing EMS providers. Contact our Division or NH Employment Security for details and question.
 - Funding is expected to be available through the end of 2024.

Special Projects

- We have partnered with the Maine and Vermont Fire Training Academies on a federal grant to develop an EV training curriculum, fund EV training and a train the trainer program throughout all three states. The full application for the grant was submitted on April 30th for a three-year project, \$420,000 for each state specifically for delivery of EV training.
- > We continue to work on our website transition and improvements with NH DoIT.

➤ We are partnering with the International Society of Fire Instructors to bring their *Water Mapping* program to the Fire Academy. Part of this project will be constructing the prop, offering a train-the-trainer program and then a student offering of the class this July.

<u>Facilities</u>

- > We continue to make needed improvements and repairs to the "A" building.
- Ongoing maintenance and repairs continue to be done in the "J" building on window frames and interior doorways.

Legislative/Administrative Rules

- > The Fire Standards and Training Commission amended Fire rules relative to the Recruitment and Retention report and its recommendations have been submitted to the Joint Legislative Committee on Administrative Rules (JLCAR).
 - The Commission will be holding a public hearing on September 5, 2024 at 9:30am on the changes to the Fire administrative rules.  - We attended the Souhegan Mutual Aid meeting in June.
- Staff members continue to attend various stakeholder and mutual aid group meetings and make department visits.
- We continue to work with the State Fireman's Association leadership to plan for the annual FF Memorial in September.

 - These rules outline the procedure for request a waiver of training standards for full-time career fire service personnel, how the determination is made to grant or deny a waiver, and the duration of a waiver if granted, which is only valid while the employee granted a waiver is employed in that position.

CURRICULUM

Professional Development Committee _ (Director Cutting)

Director Cutting reiterated the report on seminars from the Executive Director.

Fire Standards and Training Commission - (Chiefs Clark/DeAngelis) -

The results of the last meeting of the Commission, which was May 2, 2024 was previously reported. The next meeting of the Commission is not scheduled until September 5th when the revised curriculum for Hazardous Materials Awareness and Operations will likely be accepted for public comment.

The Visiting Committee for Haz-Mat Awareness and Operations has completed their review and presented their findings and recommendations to the Curriculum Committee this week. Haz-Mat Awareness had no significant changes from the prior version, however for credit by the Fire Academy for Firefighter 1, the exam must be proctored in person by the Academy. The number of questions on the exam has been increased to 50.

The Haz-Mat Operations level is a complete revision with significantly more skills needed to be demonstrated. There was discussion concerning if PPE/SCBA should be a prerequisite or just a recommendation. Further discussion is needed at the August Curriculum Committee meeting to make a recommendation to the Commission to establish the required public hearings.

The Curriculum Committee briefly reviewed the Academy's recommendation to revise the Vising Committee policies and the Curriculum approval process. No significant changes were discussed and more discussion with a recommendation will be held at the August meeting to be presented to the full Commission at their September meeting.

The Fire Inspector Curriculum Visiting Committee will meet this month and review significant changes in NFPA 1031 which now is incorporated in NFPA 1030 which deals with Fire Inspectors and the change in classification of Fire Inspectors to First Responder Inspector, Fire Inspector and Plan Examiner certifications. It is anticipated that the Visiting Committee will complete their analysis and report in late Fall to the Curriculum Committee.

Next meeting of the Commission is September 6th.

NH Emergency Medical and Trauma Services Coord. Board – (Dep. Chief Paquette) –

The Emergency Medical and Trauma Services Coordinating Board met May 16, 2024.

A review / update from the Bureau of EMS / Chief Romanello.

The rules for the Education Training Agency have been released. I believe this transitions the instructor coordinator model to a business or Agency based model. There is information posted on the Academy website.

An update from regarding the Coordinating Board's legislative interests including House Bills 1330 – Disciplinary review committee (essentially dead), 1057 Relative to provisional licenses for EMS providers (I believe this passed, going to senate). Senate Bills: 407 – relative to a ground transport cost reporting program, and SB 409 relative to state Medicaid funding of treat and release patients.

In the past, Chief Wilking (retired from Exeter) had questioned whether the NHAFC would be willing share the information and bills the Association is interested in, via our lobbying presence, with the Coordinating board to maintain a cohesive and complementary list.

The new protocols, version 9.0 was released and placed in effect June 1.

The board voted to pen a letter to the Commissioner of Safety related to removal of names of providers from the compliance website after the provider has passed away. The Board discussed barriers to EMS student ride times due to child labor laws, especially under 18, CRTC, HS programs, etc.

The Board discussed the CARES project for cardiac arrest registry, ARC would cover the cost for the first two years, but then it seems cost prohibitive subsequently at \$17k/year. The board discussed the building of curriculum for the annual provider mental health continuing education.

Trauma rules Saf C8300 were approved by the board.

The next meeting is July 18, 2024.

National Volunteer Fire Council (NVFC) – (Chief) –

The Board of Directors, at their meeting on July 10, 2024 have selected Chief Erik Thomas of Atkinson as the new representative to the NVFC and Chief Scott Cathy of New Hampton as Alternate.

EMS Trauma Medical Review Committee (Dep. Chief Clough) – (Submitted in writing for the minutes)

1) EMS Bureau Reports -

a) Upcoming meetings on July 18th for MCB & CB, privacy committee meeting for June 26th has been cancelled.

b) Protocols 9.0 were released with a June 1, 2024 date of implementation. 81% of providers have taken the new rollout, it is the responsibility of the units to ensure their providers have taken it.

c) Specialty services is interviewing to replace Matt Robblee.

d) As of June 3, 2024 there are 5708 licensed providers in the state. 500 are nonaffiliated.

e) Educational Training rules were released on May 10th, 31 instructor coordinators provide initial Ems education. The national registry has discontinued the psycho-motor exam for ALS providers, and in our rules every course must include a psycho motor element, the Division will own the ALS exam for the next 11 months in conjunction with the BLS exams. Portfolio based assessments are encouraged.

f) Several part time positions open in operations, interviews ongoing.

g) The EMR program is going strong, funding will be ending the first of the year.

h) 45 active investigations in compliance currently.

i) 500 trauma kits have been distributed to State facilities.

j) New software for the development of protocols is being reviewed and will be announced closer to the next roll out. This will make it easier to modify etc.

k) The work invest program had 2.5 million dollars to spend, only \$450,000 has been spent on this program. A discussion was held about why this program did not do as well as expected.

2) Subcommttee & Topic Reports -

Item 1: Trauma Registry Sub-committee-Walter Trachim

- The data group did not meet in May or June, the next meeting will be scheduled after the NTDB 2025 dictionary is released.
- 25, 366 data reports were collected. Developing some reporting for the trauma registry.
- AIS (abbreviated injury scale) 2015 reporting will become mandatory from the ACS for entities that report data.
- Some issues with patient registry in some hospitals, this is being looked at.

Item 2. Coordinating Board Report- Craig Clough

- CARES presentation and discussions on how the data is utilized and funding.
- The CB voted and passed the Saf-C 8300 trauma rules as presented.
- There was also a vote to recommend to the Commissioner to remove the names of deceased providers from the compliance and licensing website who had violations.
- Discussed barriers for EMS students and ride times due to child labor laws etc.

Item 3. Medical Control Board Report- Tom Trimarco

• CARES presentation, same discussions were held as CB.
