#### National Firefighter Registry (NFR) for Cancer:

The Center for Public Safety Excellence (CPSE) Board of Directors recently voted unanimously to formalize their support for the <u>National Firefighter Registry (NFR) for</u> <u>Cancer</u>. A copy of the letter of support can be found along with support letters from other fire and emergency service organizations on the <u>NFR website</u>.

In 2018, Congress passed the Firefighter Cancer Registry Act, which directed the National Institute for Occupational Safety and Health (NIOSH) to develop a registry to study cancer among firefighters. The National Firefighter Registry for Cancer is the largest effort ever undertaken to understand and reduce risk of cancer among U.S. firefighters.

Firefighters can join the NFR through the secure <u>web portal</u>. Participation is voluntary. Registration will take about 30 minutes. The NFR is a long-term project that will include voluntary, but important, follow-up questionnaires.

The NFR is open to all U.S. firefighters, not just those with a previous diagnosis of cancer. Having many types of firefighters join the NFR is crucial to examining relationships between firefighter activities and cancer. NIOSH encourages all firefighters to participate in the NFR, including:

- Active, former, and retired firefighters
- Career, paid-on-call, and volunteer firefighters
- Structural firefighters
- Wildland firefighters
- Industrial firefighters
- Military firefighters
- Instructors
- Fire investigators
- Other fire service members

#### LEGISLATIVE REPORT:

- **2024 Bill Titles -** The filing period for 2024 legislation has passed for both the House and Senate. At this point, we can only see the titles of the bills and the sponsors. The attached list includes all of the bill titles we have flagged for NHAFC for 2024. Senators can also file "confidential" legislation, meaning that the title is never made public. We may not get to see all of the titles that impact the Association before the session begins. We should start to see text of the legislation later this month and early next month.
- HB 373 (Ambulance Billing)/Ambulance Summit The discussions regarding ambulance services started with the introduction of HB 373 during the 2023 session. The bill sought to prohibit "balance billing" for ambulance services. It was retained by the House Commerce Committee after NHAFC and a number of ambulance providers testified against the bill. Subsequent to the Legislative session, NHAFC was invited to participate in an "ambulance summit" at the NH Department of Insurance. The goal of the summit was to bring together regulators, insurance carriers, and ambulance providers to address a number of issues, beyond balance billing, which impact the provision of service.

In a recent working group meeting, the Department discussed their concept of prohibiting balance billing while creating a fee structure to re-imburse ambulance services. The intent is design a fee structure which ensure that no provider lost revenue under the new system. Included with the report is a presentation from the Department outlining the concept. Slide 7 includes the high level overview. Ambulance service providers have been asked to provide written comments on the concepts. NHAFC will be preparing a letter with our thoughts.

NHAFC was appreciative of all of the members who took the time to respond to the ambulance rate survey. It has been helpful for the continued discussions with the Department.

- Retirement Benefits Commission During the debate on the state budget, language was removed, which would have eliminated the "middle tier" in Group II. The language to eliminate the middle tier was replaced a Study Commission consisting of legislators and participants (employer/employee) in the retirement system. There is consensus that any restoration of benefits would be "pre-funded" to avoid any employer costs assessments. The initial cost estimates for pre-funding the revisions to benefits were higher than some legislators had hoped. Discussions continue about alterations which will restore some benefits without additional costs to employers. There has been a focus on altering the multiplier upward in hopes of retaining some of the members in the middle tier. The Commission is scheduled to meet again on November 8. At that time, there could be a final proposal for legislation in the 2024 session.
- E-911 Personnel Training Study Committee Governor Sununu signed HB 376 into law earlier this year. The bill created a study committee to examine the education, training, and requirements for E-911 dispatch for fire, police, and EMTs. The committee is tasked with recommending regarding uniformity in training/certifications. In the final report, the committee recommended that any existing staff that has not been on the job more than 1 year would need complete 40 hours of any of the following trainings:
  - Any ANSI-compliant basic telecommunicator curriculum
  - Training and testing of the following NH Modules:
    - NH State Resources

- Air Medical Resources
- NH Right to know and confidential information handling
- NH Search and Rescue Resources
- NH Fire Mobilization plan
- NH 911 and Emergency Dispatch processes
- NH Telecommunications Response Team resources

All agencies would annually report to the Department of Safety a roster of all currently employed communications personnel. This report and its requirements will likely be a bill in 2024.

# Sgt. At Arms (Hunter) –

• He explained the details of meetings of the Ambulance Billing Committee. Chief Sitar offered the following:

The Ambulance Billing Committee was organized to look at legislation regarding eliminating ambulance transport balance billing to the patient. The goal of the committee is to eliminate balance billing to the patient. The committee is divided into three sub-committees:

- System Efficiencies this sub-committee is looking at alternate delivery methods, including community paramedicine and billing for treat no transport.
  - Treat/no transport is a billable service in most cases. Education is needed to spread this information to municipal providers.
- Facility to Facility Looking at ambulance availability in providing timely interfacility patient transport. This is mostly a private ambulance company issue, although some municipal services offer this service.
- Commercially Reasonable Rates Looking at how the State can implement, either through legislation or regulation, a flat rate on emergency ambulance transports. This would eliminate patient balance billing, except for patient copays or deductibles.
  - Rates would be different based on whether the service was urban, rural, or super rural. The rate would be based on the Medicare rate plus a percentage. The Insurance Department issued a survey to help them collect data from ambulance services to help them develop the rates the State would charge.
  - The survey was cumbersome, and the language used is not what most municipal representatives would recognize or be able to provide.
  - The Insurance Department gets certain information from insurance companies and was trying to use the survey to parse out that information for individual municipal services. This is very hard or impossible for most services to do.

• The Rate that the State would implement has nothing to do with the actual cost of service.

Chief Hunter issued a survey that I think better collects data that reflects actual costs to the municipal service.

For a municipal service, any revenue lost through the inability to balance bill or due to an appropriate rate mandated by the State, will be on the backs of the local taxpayers.

# <u>Fire Marshal</u> – (Marshal Toomey)

#### **ADMINISTRATION:**

#### <u>Personnel:</u>

We currently have 1 part-time vacancy that we are actively recruiting for at this time:

Part-time Building Code Review Board Administrative Secretary

#### Legislation:

There are 882 legislative service requests (LSR's) filed for the upcoming session. We are watching for language on 38 of these at this time. We will work to evaluate the LSR's and share information as it becomes available.

#### **Board of Fire Control:**

The next Board of Fire Control meeting is scheduled for January 17, 2024. Everything is submitted to update the State Fire Code to the 2021 editions of NFPA 1 & 101.

#### Foam Take-back Program:

The contract for the foam take-back program was approved by the Governor & Executive Council at the end of June. DES has advised the project has been delayed due to trucking issues with the subcontractor. Additional information will be released as the details are finalized.

#### **Strategic Planning Initiative:**

Our office is working over the next several months to develop an updated strategic plan which will be part of an overall Department of Safety plan.

# **BUREAU OF INVESTIGATIONS:**

In the month of October, we received 12 incident notifications resulting in 5 scene responses. The Bureau of Investigations currently has 20 open arson or suspected arson investigations.

#### <u>New cases (synopsis of some of our cases are listed below):</u>

- On October 9, an FMO investigator assisted the Plaistow Fire Department investigate a structure fire of undetermined cause but no criminal indicators.
- On October 14, FMO investigators and an IGL canine team responded to Hampton to investigate a structure fire of a vacant residence. The cause classification is suspected to be incendiary, and this is an active arson investigation.
- On October 27, FMO investigators and an IGL canine team assisted the Lebanon Fire and Police Departments investigate a fire at an apartment building under construction. LPD arrested an 18-year-old male and 17-year-old male that were responsible for setting the fire.

# <u>Fatal Incidents:</u>

- On October 5, FMO investigators and an IGL canine team assisted the Nashua FD investigate a fire that resulted in the death of one resident. Two residents were hospitalized but survived. The cause is suspected to be from an accidental electrical issue.
- On October 27, FMO investigators assisted the Hooksett Fire and Police Departments investigate an explosion and fire that resulted in serious bodily injury to a man. At this time, it appears that the man had accidentally caused an explosion of gasoline vapors while working on a vehicle. The man later died as a result of his injuries.

# Ignitable Liquid Detection Canine Teams:

• In addition to the deployments shown above, a training day was conducted with our IGL canine teams with the assistance of NH State Police's Marine Patrol. The training focused on marine operations, boat safety, building sniffs and outdoor area searches.

# Youth Firesetter:

• There were 3 youth fire setter assessments and 1 inquiry in October.

#### <u>Arrests:</u>

• We assisted the Lebanon Fire and Police Departments investigate a fire that resulted in two arrests.

#### <u>Training/Committees:</u>

• Our three newest investigators have completed the Fire Investigator Certification course at the New Hampshire Fire Academy. Two investigators attended Google geofence warrant training.

#### **BUREAU OF BUILDING SAFETY & CONSTRUCTION:**

#### State Building Permit System:

We processed the following permits in the month of October:

- Building: 39
- Electrical: 13
- Plumbing: 6
- Mechanical Fuel Gas: 6
- Mechanical Non-Fuel Gas: 5
- Fire Protection: 2
- Fire Alarm: 3

#### <u>Technical Assistance, Educational & Healthcare Reviews:</u>

We initiated 11 educational and 17 healthcare plan reviews, completed 259 inspections and 137 technical consults in the month of October.

#### Variance Requests:

We processed 6 variance requests in the month of October.

#### <u>Modular Building Program</u>

We completed 9 modular building inspections in the month of October.

# **BUREAU OF OUTREACH & EDUCATION:**

#### <u>Hazardous Materials:</u>

Hazardous Materials response, coordination and consultation is available through the on-call FMO supervisor.

Our Hazardous Materials Coordinator is available for PEAC Software training for fire departments. PEAC is used for documentation of Tier II facilities and chemical storage.

In the month of October, our Hazardous Materials Coordinator provided a chemical identification training to members of our Bureau of Investigations. He also provided CAMEO training to the Southeastern NH Haz Mat Team and a presentation to the Nashua REPC on Tier II Reporting. He also coordinated with the Southeastern NH Haz Mat Team to secure grant funding that provided four days of hazardous materials air monitoring training to the nine regional Haz Mat teams.

In the month of October, our Hazardous Materials Coordinator attended the virtual National SERC Meeting and the monthly PEAC Software Training.

#### <u>Electric Vehicles and Lithium-Ion Batteries</u>

We have held two meetings to discuss the challenges of electric vehicle fires and lithium-ion batteries. The meetings have included representatives from the State Fire Marshal's Office, Fire Academy, HSEM, State Police, DMV, DES, DOT, Tow Association, Auto Dealers Association, Clean Energy NH, NH Chiefs of Police and the NH Association of Fire Chiefs. Another meeting is scheduled for November 21<sup>st</sup>.

The International Code Council has established an ad-hoc group to evaluate building and fire code impacts from electric vehicles and lithium-ion batteries. The National Fire Protection Association Research Foundation is conducting a study. UL's Fire Safety Research Institute is also conducting a study. UL FSRI will be launching a lithium ion battery educational outreach initiative in mid-November.

#### <u>Regional Outreach/Chief's Roundtables:</u>

We continue to partner with the Commissioner's Office, other Department of Safety Leadership and the NHAFC to conduct regional outreach/Chief's Roundtables.

# Incident Reporting:

2023 is quickly ending and we ask that you submit your data as soon as possible. Your commitment to ensuring we have great data to accurately show the fire problem in NH is greatly appreciated! If you are having difficulty sending your data or need assistance, please reach out to our team at <u>NHESR@dos.nh.gov</u>.

Did you know that we are transitioning away from accepting data via email attachments? If you are a department that submits via email attachment and have not yet created a Secure File Transfer Protocol (SFTP) Account, please reach out to our team for

assistance. Our goal is to have all departments submitting data via the SFTP on or before January 1, 2024.

Have you looked at your .err files lately? These are important files that you likely receive on a monthly basis that contain invalid incidents, a.k.a. error messages. We can help you through the process so that you can resubmit any invalid incidents and receive full credit. Please contact us at <u>nhfirs@dos.nh.gov</u>.

We continue to work with the team at the Fire Academy as departments implement the NHESR program, available free of charge, for incident reporting. If you are interested in having a presentation on the program or would like to request one, please email <u>NHESR@dos.nh.gov</u>.

In May, the U.S. Fire Administration (USFA) announced their effort to launch a new fire information and analytics platform, known as the National Emergency Response Information System (NERIS), for the American fire and emergency services. Once NERIS is developed and operational, USFA will work to migrate fire and emergency services departments onto the new platform. The legacy NFIRS will remain operational throughout the transition process so all fire and emergency services departments should continue to use the current NFIRS data system and maintain status quo until migrated to the new platform. 
#### **Outreach Events:**

# <u>Grants</u>

# Special Projects

- In mid-October we announced the launch of the "On My Time" Firefighter I and II Training program.   - To date nearly 300 online modules have been completed by students in this program.
- > We have begun the planning process for our website transition and improvements with NH DoIT.
- > We have coordinated with DoIT on an assessment of our classroom technology and are awaiting the recommendation report.
- The Law Enforcement Officers, Professional Firefighters and Emergency Medical Technicians Career Development, Recruitment and Retention Program committee established in New Hampshire RSA 188-F:70 met on October 12<sup>th</sup>. The final meeting will be held in early December at the Fire Academy.
- > We have expressed our interest in participating with the North American Fire Training Directors and the National Volunteer Fire Council on a project funded through an Assistance to Firefighters Grant titled *Understanding the Role of Training on Volunteer Firefighter Recruitment and Retention*.

- This two-year project aims to better understand the role that training plays on volunteer fire service recruitment and retention, and to provide recommendations for future associated considerations and implementation by volunteer fire departments and training academies. It also works to determine whether or not a correlation exists between training and volunteer firefighter recruitment and retention. Principal partners for this project include Fire Protection Research Foundation, the National Volunteer Fire Council (NVFC) and the North American Fire Training Directors (NAFTD).

# <u>Facilities</u>

#### Building Code Review Board - (Marshal Lennon/Chief Conley) -

- Dwelling Units Sprinkled
  - An automatic sprinkler system shall not be required in up to four dwelling units where the following are met:

a. Building is three stories or less in height undergoing a change in occupancy to Group R-2 containing not more than four dwelling units and does not include congregate living. Building does not involve an increase in height or area except for egress or accessibility.

- b. Each dwelling unit has either:
- a. An exit door directly to the exterior at the level of exit discharge,

b. Direct access to an exterior stair serving a maximum of two dwelling units on the same story, or

c. Direct access to an interior stair serving only that dwelling unit and separated from all other portions of the building with 1-hour fire resistance rated fire barriers.

c. Dwelling units have emergency escape and rescue openings in accordance with IBC Section 1030.

Much of the discussion had to do with Group R-2 & R-3 Occupancy Types as well as renovations being greater than 50%. More to follow at the next meeting.

Egress as it relates to Group R-2, R-3, & R-4 Occupancy Types including basements and sleeping rooms.

Recovery Housing complying with RSA 153:10-D, this became tabled in order to identify the true definition of a Recovery House.

Solar Panel amendment was discussed and approved: **R324.6 Roof access and pathways.** 

Roof access, pathways and setback requirements shall be provided in accordance with Sections R324.6.1 through R324.6.2.1. Access and minimum spacing shall be required to provide emergency access to the roof, to provide pathways to specific areas of the roof, provide for smoke ventilation opportunity areas, and to provide emergency egress from the roof.

#### **Exceptions:**

1. 1.Detached, non-habitable structures, including but not limited to detached garages, parking shade structures, carports, solar trellises and

similar structures, shall not be required to provide roof access.

2. 2.Roof access, pathways and setbacks need not be provided where the code official has determined that rooftop operations will not be employed.

3. 3. These requirements shall not apply to roofs with slopes of 2 units vertical in 12 units horizontal (17-percent slope) or less.

4. 4.BIPV systems *listed* in accordance with Section 690.12(B)(2) of NFPA 70, where the removal or cutting away of portions of the BIPV system during fire-fighting operations has been determined to not expose a fire fighter to electrical shock hazards.

5. Access pathways are not required where PV arrays occupy up to 50 percent of the plan view roof area with a common horizontal ridge.

#### R324.6.1 Pathways.

Not fewer than two pathways, on separate roof planes from lowest roof edge to ridge and not less than 36 inches (914 mm) wide, shall be provided on all buildings. Not fewer than one pathway shall be provided on the street or driveway side of the roof. For each roof plane with a photovoltaic array, a pathway not less than 36 inches wide (914 mm) shall be provided from the lowest roof edge to ridge on the same roof plane as the photovoltaic array, on an adjacent roof plane, or straddling the same and adjacent roof planes. Pathways shall be over areas capable of supporting fire fighters accessing the roof. Pathways shall be located in areas

with minimal obstructions such as vent pipes, conduit, or mechanical equipment. **Exception:** 

Access pathways are not required where PV arrays occupy up to 50 percent of the plan view roof area with a common horizontal ridge.

# R324.6.2 Setback at ridge.

For photovoltaic arrays occupying not more than 33 50 percent of the plan view total roof area with a common horizontal ridge, not less than an 18-inch (457 mm) clear setback is required on both sides of a horizontal ridge.

For photovoltaic arrays occupying more than 33 50 percent of the plan view total roof area with a common horizontal ridge, not less than a 36-inch (914 mm) clear setback is required on both sides of a horizontal ridge.

In October, the Division of Emergency Services and Communications utilized its social media platforms (Facebook, Twitter, and Instagram) to educate the public on text to 911 and knowing your location, share information about Sudden Cardiac Arrest Awareness Month and the importance of AEDs, and recognize employees all around the Division, including those completing our Portsmouth data collection project – a massive undertaking! Additionally, we showcased our public education and outreach initiatives with pictures of our visits to several schools and local fire departments, and kept our audience informed by sharing relevant fire prevention messaging from our partner agencies.

- Met with DNCR and the folks from NH ARES (Amateur Radio) regarding colocating equipment on their Towers to enhance emergency Communications capabilities as part of the ESF-2 role in the State Emergency Operations Plan;
