- Legislative update
- Notice of retirement program from NHFA on Friday June 16, 2023 for Scott Cathy for his promotion to New Hampton fire chief's position.
- NH Hazmat conference surplus grant of approximately \$16-17K to be allocated between the two programs. The goal is to include fire/EMS/and LE.
- NHAFC will be delivering three educational programs on Electric Vehicle fires at the NHFA on July 7-8, 2023.
 - The Seacoast Chief Fire Officer Mutual Aid District has been working with Hank Thomas to co-sponsor EV training on August 29, 2023. The District has secured Dover High School for the large capacity venue and is planning to deliver two offerings. The speaker has been booked and the NH Towing Association has reserved 100 seats for the program.

IAFC Safety Stand Down 2023

The 2023 Safety Stand Down takes place June 18-24 and focuses on lithium-ion battery response with the theme "Lithium-Ion Batteries: Are you Ready?" Five daily focus areas highlight different aspects of this critical safety topic. Additional planning materials and resources will be added to this web site leading up to Safety Stand Down. Taking place each year during the third full week of June, Safety Stand Down highlights critical safety, health, and survival issues for fire and emergency services personnel.

Departments are asked to suspend all non-emergency activities during the week to focus their attention on safety and health education efforts. A week is provided to ensure that all duty shifts can participate. The 2023 Safety Stand Down takes place June 18-24 and focuses on lithium-ion battery response. - NIOSH National Firefighter Registry (NFR) for Cancer is live
 The National Firefighter Registry (NFR) for Cancer is the largest effort ever undertaken to understand and reduce risk of cancer among U.S. firefighters. NIOSH is recruiting firefighters to join the NFR so that we can better understand the link between firefighting and cancer. Firefighters are exposed to chemicals on the fireground that could increase their risk of developing cancer.
